
Description of the product

The main fuction of SpaceLogic KNX Valve Drive Controller is to actuate thermoelectric valve drives for heating or cooling ceilings.

Functional unit

The device actuates switching of electrothermal actuators for heaters or cooling ceilings. Switch-on and Switch-off during the drive's cycle time achieves an almost constant behaviour. Integrate room temperature control with setpoint value specification. It has six independent controllers to control up to six independent rooms. Installation in sub-distribution units on DIN rail according to EN 60715 for 10 years.


