The JSD-TD25P-021600 is a mobile two-hand-device with two Safeball and integrated EDEN Sensor EVA. The connection is realized via a spiral cable 1/5m.

Operating buttons have been integrated into the laterally mounted Safeball in such a way that they support ergonomics and manipulation safety during handling.
