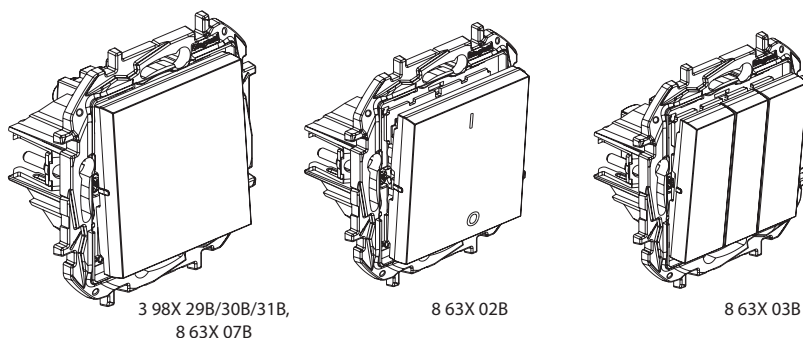


1. USE

Lighting controls mechanisms.
Flush or surface mounting.
Screw or screw and claw mounting with claws.
To be fitted with one-gang or multi-gang plates.

8 63X 07B : 2 x 2.5 mm²
8 63X 03B : 4 mm²
Stripping length: 10 mm
